If you believe your rights have been violated, request to see your union steward You have the right to file a grievance and speak to your steward while on the clock Do not delay in doing this as there are critical time limits in which grievances must be filed (14 calendar days from the date you first learned of, or should have learned of the grievance) Once you have completed 90 ...
